

### **English Learner Supports for Region 2**

As we move toward transitioning to the requirements of Every Student Succeeds Act (ESSA), I wanted to keep you aware of some of the implications for our English Learners. The following key points are taken from a webinar by Dr. Wayne Wright from Purdue University. This 20-minute webinar will give you some other new information and may cause you to have some additional questions or concerns. For that reason, and to better support the needs within our region we now have an active EL Network.



- Change from "limited English Proficient" (LEP) to English Learners (ELs)
- Removable of unrealistic expectations like 100% of ELLs passing all state tests by a given year
- Requirement for an ELL Subgroup means needs of ELLs can't be ignored
- Move of English Language Proficiency Standards and Assessments from Title III to Title I raises its importance in school accountability plans
- More flexibility in goal setting, interventions
  Specific interventions may be required for schools with poor ELL performance
- Some relief from ELL test scores in school accountability formulas in first 2 years
- Teacher evaluations not tied to invalid ELL test scores
- Some consideration of ELL students' ELP levels in accountability
  - Some consideration of growth over time

#### New Self-Paced Online Course Now Available: Literacy Development for English Learners

This self-paced online course is designed to provide teachers and administrators with an overview of research-based approaches to literacy and biliteracy development for English learners (ELs) in the mainstream classroom.

Based on decades of research by the Center for Applied Linguistics on how language is learned and extensive experience working effectively with educators to help English learners succeed in the classroom, the *Literacy Development for English Learners* online course is divided into three modules designed to provide an overview of research-based approaches to literacy development.

In this course, the three modules will be dedicated to areas associated with literacy: connecting literacy practices with student backgrounds, reading, and writing.

Each module begins with a warm-up activity and includes a narrated PowerPoint presentation and readings. Throughout the course, participants have opportunities to reflect upon and practice new learning, self-assess through quizzes; view real-world examples through video demonstration; and apply lessons learned through applicable wrap-up activities.

Module 1 provides an introduction to literacy development as participants explore their own personal definitions of literacy development and compare their experiences to those of English learners.

**Module 2** explores ideas about vocabulary and reading skill development through concepts and critical thinking as new language knowledge is acquired and cultivated.

• **Module 3** focuses on English language writing development and practices that teaches can employ to promote writing abilities and interest among their English learners.

Upon registration and payment, you will receive log-on credentials for the course via the email address provided upon registration.

Each module is self-paced and takes approximately two hours to complete. You will have three months to complete the course. At the conclusion of the course, participants will receive a certificate of completion from the Center for Applied Linguistics.

CAL also offers a tiered pricing structure for schools and districts who wish to have 10 or more teachers take the online course.

Participants will utilize tools, guiding questions and procedures developed and utilized by the Ohio Department of Education, Office for Exceptional Children to conduct an internal review.

Topics covered include the Strategic Improvement Self-Review (SISR), record reviews, perception surveys, data analysis, district strengths and challenges and Strategic Improvement Plans. ## Ohio's Evolving Positive Behavior Interventions and Supports Implementation

Upon entering schools throughout our region, it is very likely one will find the evidence of Positive Behavior Interventions and Supports (PBIS) implementation. These observations could include banners detailing the 3 to 5 expectations for behavior within the building, a school store or incentive program, a matrix detailing what expectations are expected in the various settings throughout the building, and parent and community connections to the school's social emotional support system. This implementation is part of Ohio's ongoing efforts to make our schools not only academically superior but also a safe place in which students, staff and parents support each other's social and emotional well-being.

PBIS was written into Ohio law in January of 2013 and adopted by the Ohio Department of Education under Rule 3301-35-15, stating:

(7) "Positive behavior intervention and supports" means

(a) A school-wide systematic approach to embed evidence-based practices and data-driven decision making to improve school climate and culture in order to achieve improved academic and social outcomes, and increase learning for all students, and that

(b) Encompasses a range of systemic and individualized positive strategies to reinforce desired behaviors, diminish reoccurrences of challenging behaviors, and teach appropriate behaviors to students.



Since that date, Ohio's State Support Teams, in collaboration with The Ohio Department of Education, have made statewide implementation of PBIS one of their major goals. The statewide PBIS Network continues to be a driving force in this endeavor. This year, in addition to the PBIS Universal Team Training, the State PBIS Network has approved a PBIS Tier 2 Training that will help schools focus on supporting students, in small groups, whose needs dictate more direct supports around the social emotional growth of the students.

In Region 2, PBIS facilitators, from buildings and/or districts, will be invited to quarterly PBIS Network meetings that will help address the ongoing needs for updated ideas and tools to help support students' social/emotional growth. These network meetings will be hosted by SST PBIS Consultants and provide a space to share what is working and what PBIS challenges still exist in your building.

Here's to a great 2016-17 school year! Remember, behavioral errors, like academic errors, should first be seen as a chance to reteach, refocus, and realize that social/emotional growth takes outstanding teaching as well!
