Revised Operating Standards for Ohio Educational Agencies Serving Children with Disabilities Went into Effect July 1, 2014

The revised Operating Standards for Ohio Educational Agencies Serving Children with Disabilities went into effect July 1, 2014. There were numerous changes to the Operating Standards (Ohio Administrative Rules 3301-51-01 to 3301-51-21) and a few of the changes were previously placed into effect prior to July 1, 2014. Three such changes are: “the IEP can no longer serve as prior written notice” (went into effect December 2013); “districts must provide notice of the Autism Scholarship and John Peterson Scholarship to parents” (in effect 2013) and “comprehensive transition services for students at age 14, or earlier if the IEP team determines appropriate” (in effect 2013-2014). In order to provide readers with a brief synopsis we have only highlight a few of the changes in this article. It is imperative that readers read the revised Operating Standards for Ohio Educational Agencies Serving Children with Disabilities themselves and in no way should they rely solely on this article for information. This article is meant to provide the reader with general information and is not legal advice.

OAC Rule 3301-51-01 Applicability of requirements and definitions:

- Deletion of “cognitive disability” as a disability category; the appropriate term is “intellectual disability.”
- The entities that previously were called County Boards of MRDD are now Boards of Developmental Disabilities.
- When identifying a child between the ages of 3 and 5, the term “developmental delay” is now an available disability category.
- Clarification between the required members of an initial evaluation team and the required members of a reevaluation team has been provided.

STARS Information

WHO: Anyone who wants to register for professional development

WHAT: The Ohio Department of Education (ODE) launched the Security Application For Enterprise (SAFE) Web portal in May, 2003. SAFE is a Web Portal and a "single sign on" software security solution for ODE customers. The SAFE sign-up procedure is automated and authenticates users by leveraging real-time Ohio driver license and Ohio identification data.

WHERE:

WHEN: Individuals need to register for workshops through STARS for each session they plan to attend.

WHY: The portal provides ODE customers with an added measure of convenience. Eventually, an individual will need only one secure account for most ODE Web applications he or she is authorized to use. ODE customers expressed frustration with the large number of passwords and custom security systems rolled out with each new Web application. SAFE addresses those concerns and provides customers with one "portable" password and username for a variety of ODE Web applications. SAFE also provides a centralized and consistent security approach and electronic signature authority for electronic transactions.

SAFE is sometimes referred to as the "Web Portal," so "SAFE account" and "secure ODE Web Portal account" are synonymous. Additionally, State Support Team Region 2 COMMUNICATES TO REGISTRANTS THROUGH STARS: CHANGE OF LOCATION, CANCELLATION, ETC. IS SENT VIA THE EMAIL IN YOUR USER PROFILE.


Introducing the newest members of the State Support Team for Region 2...




Janet McGlugrith

STARS Information

HOW: The SAFE sign-up procedure is automated and authenticates users by leveraging real-time Ohio driver license and Ohio identification data. To access a secure Web application, two things must occur. First, users must request their own SAFE account, which has a unique account name and password. Second, they must have the appropriate role (or roles) assigned to them in OEDS by their OEDS and/or SAFE administrator. If these two requirements are met, then users should automatically be granted access to the application(s) for which they have authorization. SAFE also supports roles/groups not included in the OEDS system.

Registration is FREE and REQUIRED;

- Sign into your SAFE account – (Establish an account -if you do not currently have one, then select STARS V2.0 and complete your user profile – one time only)
- Select: Event Search
- Search by: Region 2
- Starts between: Enter the Date of the training
- Highlight the event and click: Register for Selected Event
- Follow the steps until you reach the screen to confirm your registration

Please be sure that your STARS profile has your **current** email address, as we send pertinent information using the email address of attendees and additional training information may be shared before the training

OAC Rule 3301-51-05 Procedural Safeguards

- Informed consent is required prior to accessing public benefits or insurance
- Discussions held during a resolution session are no longer confidential and may be used in subsequent hearings.
- The timeline of 10 days was removed, and no new timeline was given, regarding starting an FBA or reviewing a student's BIP when his or her misconduct is determined to be a manifestation of his or her disability.

OAC Rule 3301-51-06 Evaluation

- Districts must provide Rtl services during evaluation window if not already provided prior to referral.
- Children transitioning from preschool to KDG are not required to be reevaluated, if they have a current evaluation and are not identified developmental delay.

OAC Rule 3301-51-07 IEP

- At the time of an initial IEP, parents are required to be notified of the comprehensive eye exam.

OAC Rule 3301-51-08 Parentally placed nonpublic school children

- The revised rule provides clarification concerning details regarding a district's responsibility and children participating in the Jon Peterson Scholarship or Autism Scholarship.

OAC Rule 3301-51-09 Delivery of Services

- The rule clarifies language for intervention specialists and related service personnel regarding determination of workload. Ratios and age ranges still remain.
- District policies and procedures must now include annual professional development for Paraprofessionals.

OAC Rule 3301-51-11 Preschool children eligible for special education

- ESY services must be considered for all children transitioning from Part C to Part B, even if they have not had previous school experience.

OAC Rule 3301-51-21 Providing instructional materials to children with visual impairments and others with print disabilities that are listed for sale by publishers with the Superintendent of Public Instruction.

- The new rule replaces the previous rule and now requires publishers to provide to the National Instructional Materials Access Center (NIMAC)

The State Support Team Region 2 will be offering professional development sessions on the newly revised operating standards. "New Rules for Special Education: Shifting Focus from Minimum Standards to High Performance" is scheduled for 8/27/2014, 9/17/2014, 10/10/2014, or 11/21/2014. Participants need only to attend one session and pre registration in STARS is required.
