### YOU ARE NOT ALONE - H.O.P.E. IS HERE

H.O.P.E. - (Helping Ohio Preschoolers Excel program, formerly known as the Ohio Preschool Expulsion Prevention Partnership), is a critical resource and aims to support educators working with children ages 0 to 8 in various learning settings. The program provides rapid response consultation within 48 hours, and the opportunity for professional development, social-emotional resources, and linkages to community resources to enhance educators' capacity to create nurturing learning environments. The goal of H.O.P.E. is to reduce the risk of expulsion. This initiative equips educators with strategies and tools and promotes long-term support among professionals. 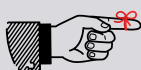
